

Expo Channel 12 Days of Christmas Competition 2020

Terms and Conditions

1. Information on how to enter and prize details forms part of these conditions of entry. Entry into the Competition is deemed acceptance of these terms and conditions.
2. Entry is open to permanent residents of Australia only. Employees of Expo Channel and their subsidiary agents and members of their immediate families are not eligible to enter.
3. To enter, watch Expo every night at 7.30pm (AEDT) from December 1 to December 12, 2020 for competition clue word. A new clue word will be broadcasted each day during the period of the competition. Log on to www.expochannel.com.au to enter your name, address, phone number, email address and the competition's clue word. Entries for each day of the competition must be submitted before 11.59pm (AEDT) on Saturday, December 12, 2020.
4. Competition opens Tuesday, 1 December 2020 at 7:30 pm, and runs for twelve days, closing Saturday, 20 December 2020 at 11.59pm (AEDT). The draw happens each day at 10:30 am from Wednesday, 02 December 2020 to Monday, 14 December 2020. Draws for the Friday and the weekends will occur on the Monday (Draws for Friday, 4 December, Saturday, 5 December and Sunday, 6 December 2020, will occur on Monday, 7 December 2020; Draw for Friday, 11 December and Saturday, 12 December will occur on Monday, 14 December 2020). For example, valid entries received Tuesday, 1 December 2020 will be drawn and announced on the website the following working day, Wednesday, 2 December 2020.
